Keep in mind that you'll need money for equipment, marketing, rent, product, and more. So be sure that you're in good financial standing to start your business.

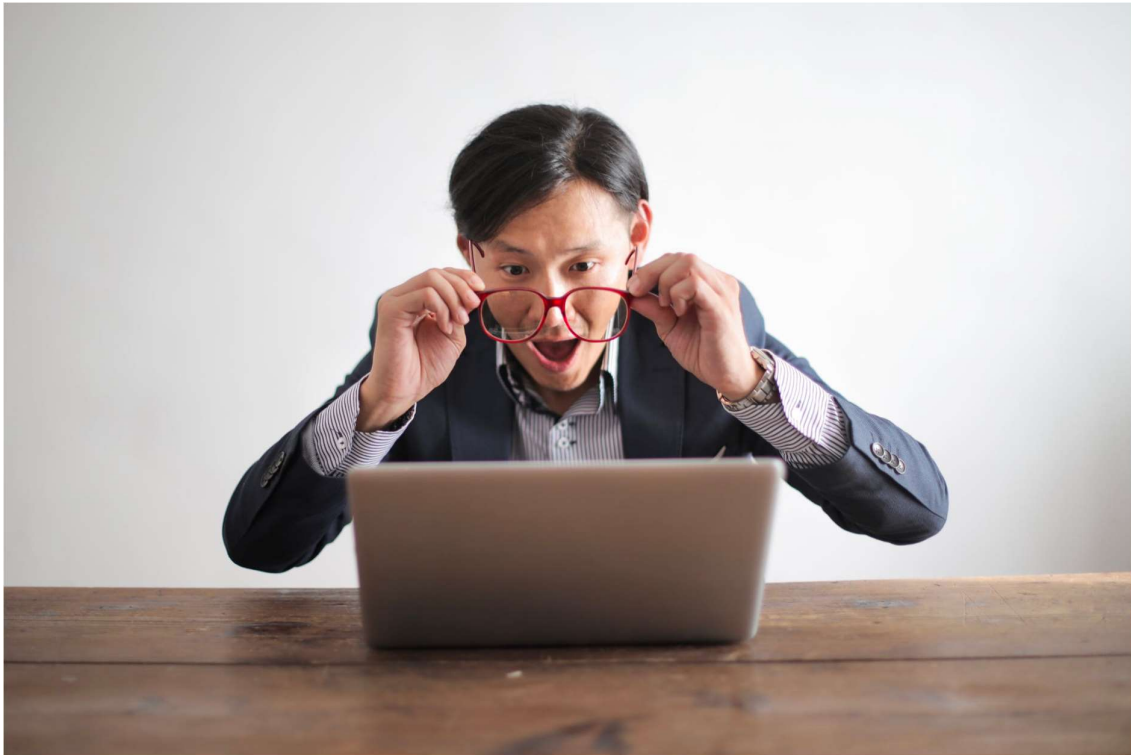
